Mayor White opened the work session and advised the Council, staff and the audience that staff would provide information and explanations about the following items:

DISCUSSION ONLY

A. DISCUSS MINUTES OF THE CITY COUNCIL MEETINGS OF AUGUST 13, 2015 AND AUGUST 18, 2015.

Mayor White requested corrections to the minutes. There were none.

B. DISCUSS CITY MANAGER'S RECOMMENDATION TO AWARD BID TO GIFFORD ELECTRIC OF FORT WORTH, TEXAS, TO PROVIDE AND INSTALL FIVE (5) BAD WEATHER OUTDOOR EARLY WARNING UNITS AND NECESSARY RELATED EQUIPMENT IN THE AMOUNT OF \$95,490 FOR COMPLETE INSTALLATION OF THE UNITS, AND APPOINTING THE MAYOR TO SIGN THE PROPOSAL, IF APPROVED.

Mr. Rodgers stated that bids were publicly advertised for a bad weather outdoor early warning system that would cover the City. Two bids were received. Federal Signal's bid of \$98,971 included installation of the individual units at the specified locations. The bid submitted by Gifford Electric included \$12,750 for labor to install the units, or a net bid of \$82,740 and a total bid of \$95,490. The system installed by Gifford Electric had better references. For example, the City of Waco Emergency Management Coordinator was and has been very pleased with the Gifford Electric system which has been in service for five years or more. The City will provide the electric poles, meter bases, electric services, and the mobile radios required for each warning unit. This system will be unique in that it will utilize the City's 800 MHz radio system in lieu of a VHF radio system. Mr. Rodgers recommended approval.

C. DISCUSS STAFF'S PROPOSAL TO PROVIDE FREE ADOPTIONS, RABIES SHOTS, AND SPAY/NEUTER SERVICES FOR ANIMALS IN THE SHELTER ADOPTED DURING THE MONTHS OF NOVEMBER AND DECEMBER 2015, USING DONATED FUNDS IN THE INTEREST OF A PUBLIC PURPOSE.

Mr. Rodgers stated that there are sufficient donated funds to provide these services for animals in the shelter during the months of November and December 2015. This would be done in the interest of a public purpose. If approved by Council tonight, that would allow sufficient time to promote and advertise. Mr. Rodgers recommended approval.

Ms. Pendergrass reported that the free adoption and spay and neuter program offered in January 2015 was a success. She stated that she believed that this subsequent free animal adoption opportunity would also be a success.

D. DISCUSS ORDINANCE 2015-20 AMENDING CHAPTER 46 "SIGNS" OF THE CODE OF ORDINANCES WITH REGARD TO (1) INFLATABLE SIGNS AND TETHERED BALLOONS, PENNANTS AND STREAMERS, STRINGS OF LIGHTS, AND FLAGS IN SECTION 46-6 "PROHIBITED SIGNS AND LOCATIONS"; (2) FLAGS, STRINGS OF LIGHTS, AND TETHERED BALLOONS IN SECTION 46-7 "SIGNS EXEMPT FROM SECTION 46-11(B)"; (3) REFORMATTING AND EXPANSION OF SUBSECTION (G) FOR BANNERS OF ALL TYPES, AND REFORMATTING AND EXPANSION OF SUBSECTION (I) FOR FLAGS AND FLAG POLES, IN SECTION 46-10 "SIGN-TYPE STANDARDS"; (4) REFORMATTING AND EXPANSION OF SECTION 46-11 "ZONING STANDARDS" TO CLARIFY THE REGULATION OF SIGNS BY ZONING DISTRICT AND IN THE EXTRATERRITORIAL JURISDICTION; (5) ADDITION OF A NEW SECTION 46-13 "MAINTENANCE"; AND, (6) RENUMBERING OF THE CURRENT SECTION 46-13 "PENALTIES AND ENFORCEMENT" TO SECTION 46-14.

Mr. Gibson stated that on March 17, 2015, the Council appointed an ad-hoc committee to review possible changes to the City's regulation of certain temporary signs, to be determined by the city manager as the types for which enforcement has been difficult or about which he had received the most complaints from business owners. The six-member committee met with staff a total of eight times beginning on May 14 and ending on August 13. The committee reviewed the City's current sign standards and the results of their research into comparable sign standards in other cities in the regions, and discussed possible changes to the Lockhart sign ordinance. A consensus was reached on all items, and the committee voted at their August 13, 2015 meeting to recommend the amendments as presented in Ordinance 2015-20. The remaining text of Chapter 46 will remain unchanged. Mr. Gibson recommended approval.

There was discussion.

Mr. Gibson stated that if the Sign ordinance amendments are approved, a copy of the amendments will be provided to each of the business owners within the city.

ITEM 3. CITIZENS/VISITORS COMMENTS.

Mayor White requested following citizen to address the Council:

Janet Tiemann, 1305 Center Street, spoke against the City paving Patton Street and suggested that it be closed.

Mayor White requested additional citizens to address the Council. There were none.

ITEM 4-A. HOLD A PUBLIC HEARING ON APPLICATION ZC-15-05 BY CHATEAU HOMES, INC., ON BEHALF OF DAVID REYES, FOR A ZONING CHANGE FROM AO AGRICULTURAL-OPEN SPACE DISTRICT TO RMD RESIDENTIAL MEDIUM DENSITY DISTRICT FOR LOT 3, BLOCK 1, CAPELLO SUBDIVISION, CONSISTING OF 10.786 ACRES LOCATED AT 1710 CLEAR FORK STREET.

Mayor White opened the public hearing at 7:48 p.m. and requested the staff background report.

Mr. Gibson stated that the applicant has requested a zoning change for the subject lot with the intent of replatting it into a single-family residential subdivision consisting of approximately 35 lots. The property is currently vacant, and is located directly across the street from the Meadows at Clear Fork subdivision, which is zoned PDD - Planned Development District. The new lots are proposed to be 65 feet wide and approximately 113.5 feet deep, and will each contain approximately 7,377 square feet. The width of the main part of the subject tract is 277 feet. In order to accommodate a 50-foot right-of-way with lots on both sides of the street, the deepest the lots can be is 113.5 feet. The applicant has requested RMD zoning because the proposed lot size corresponds to the SF-2 development type, which requires at least RMD zoning. Although the proposed lots do not meet the minimum lot size or depth needed for the SF-1 development type, the actual density with 35 lots will be only 3.25 units per acre, which is well within the low density range. The surrounding area is a mixture of open agricultural land and single-family homes. The proposed housing subdivision would be very similar in character and density to the Meadows at Clear Fork PDD on the opposite side of Clear Fork Street. The City's Land Use Plan map indicates that this area, including the subject parcel and all surrounding property, is intended for future Residential Low Density development. Although the zoning request is for RMD, the development of relatively large single-family lots does meet the intent of the Land Use Map designation. The existing constraints of the parcel, as discussed, make it impractical to subdivide the property into lots that would comply with RLD zoning. Therefore, the request for RMD zoning is appropriate. No objections were expressed in writing or in person by the public at the Planning and Zoning Commission meeting. The Commission did not object to the lot size proposed by the applicant but was concerned that, once the zoning is approved, the applicant could change his mind and legally plat lots as narrow as the 50-foot minimum allowed in the RMD district. Mr. Gibson stated staff recommended approval and that the Planning and Zoning Commission voted 3-2 to recommend denial due to the smaller minimum lot size allowed in the RMD district.

There was discussion.

Mayor White requested the applicant to address the Council:

John Grobelny of Chateau Homes, 4801 South Congress Avenue, Austin, provided details about the specifications of the houses that are planned to be built in the proposed subdivision. He requested approval.

Mayor Pro-Tem Sanchez made a motion to approve Ordinance 2015-19, as presented. Councilmember Michelson seconded. There was brief discussion. The motion passed by a vote of 5-1, with Councilmember Castillo opposing.

ITEM 4-D. HOLD THE FIRST (1ST) OF TWO PUBLIC HEARINGS ON A PROPOSAL TO INCREASE TOTAL TAX REVENUES FROM PROPERTIES ON THE TAX ROLL IN THE PRECEDING YEAR BY 3.339910 PERCENT. THE DATE OF THE SECOND (2ND) PUBLIC HEARING WILL BE SEPTEMBER 15, 2015 AT 7:30 P.M. THE VOTE ON THE TAX RATE WILL BE ON SEPTEMBER 22, 2015 AT 6:30 P.M. AT THE CLARK LIBRARY ANNEX — COUNCIL CHAMBERS, 217 SOUTH MAIN STREET, 3RD FLOOR, LOCKHART, TEXAS 78644.

Mayor White opened the public hearing at 8:53 p.m. and requested the staff background report.

Mr. Hinson stated that the Council is required by State law to hold two public hearings if the proposed property tax rate exceeds the effective tax rate. The public hearings will be to inform the public about a proposal to increase total tax revenue from properties on the tax roll in the preceding tax year by 3.339910 percent.

Mr. Hinson informed the Council and the public about the following:

- The average taxable value of a residence homestead in the City of Lockhart last year was \$108,822. Based on last year's tax rate of \$0.722700 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$786.46.
- The average taxable value of a residence homestead in the City of Lockhart this year is \$111,581. If the governing body adopts the effective tax rate for this year of \$0.709600 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$791.78.
- If the governing body adopts the proposed tax rate of \$0.733300 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$818.22.

Mayor White requested citizens to address the Council in favor of or against the proposed Fiscal Year 2015-2016 tax increase. There were none. He closed the public hearing 8:55 p.m.

Mayor White announced that the vote on the tax rate will be held on September 22, 2015 at 6:30 p.m. at the Clark Library Annex – Council Chambers, 217 South Main Street, 3rd Floor, Lockhart, Texas 78644.

The motion passed by a vote of 6-0.

Mayor Pro-Tem Sanchez made a motion to nominate Miguel Islas to continue as the City's nominee on the Caldwell Council Appraisal District Board of Directors. Councilmember Mendoza seconded. The motion passed by a vote of 4-2, with Mayor White and Councilmember Michelson opposing.
