JOB SUMMARY

The Class A Lineman installs and maintains street lights and overhead as well as underground power lines for the City and is considered a safety sensitive position. An incumbent in this position also installs single phase and three phase transformers, troubleshoots outages, reads electric and water meters, connects/disconnects service, and responds to emergency calls.

ESSENTIAL JOB FUNCTIONS

- Constructs and installs new overhead electrical distribution lines.
- Maintains and rehabs overhead distribution lines; climbs wood poles and towers.
- Trims trees away from distribution power lines.
- Installs single phase and three phase transformers.
- Constructs, maintains, and rehabs underground power lines; specializes in underground locates; ties in underground meter loops; transfers temporary underground to permanent installations; and installs underground primary lines and ties into secondary.
- Installs primary and secondary metering.
- Reads, connects, and disconnects meters.
- Maintains all City owned street lighting.
- Works on-call as scheduled; responds to emergencies within time requirements.
- Operates heavy equipment; drives to/from work sites; and maintains and stock work trucks.
- Attends work related classes and safety meetings
- Performs other related duties as assigned.

QUALIFICATIONS

Education and Experience:

Requires a High School diploma or equivalent, five (5) years of related work experience installing and maintaining overhead/undergrounds electrical distribution systems including climbing poles and towers and installing/maintaining street lights, or an equivalent combination of education and experience; additional experience in three phase and single phase transformer installations preferred. Journeyman in this field of work.

Licenses or Certifications:

• Certifications desired for the following areas: Pole Climbing; Hot Line; Transformer; Underground; Class 7 Forklift; OSHA 10; First Aid; and CPR.

Special Requirements:

- Possess and maintain a valid Texas driver's license and a good driving record.
- Obtain commercial driver's license (CDL), Class "A" or "B, within 90 days of hire.
- Maintain weight in order to meet weight requirements when using a bucket truck; combined personal body weight, materials, and tools cannot exceed 300 pounds.
- Ability to maintain regular, reliable in-person attendance.
- Ability to respond to emergencies, serve on-call duty, and respond within required time frame.
- Must be able to respond from their residence to the Lockhart City limits of service area within 25 minutes of notice by the City to a call out or the electric warehouse

- Knowledge of constructing and maintaining distribution overhead and underground power lines including connecting/disconnecting meters, framing, and installation.
- Knowledge of locating underground circuits using a locator.
- Knowledge of installation and maintenance of street lights.
- Knowledge of three phase and single phase transformer installations.
- Knowledge of safety requirements.
- Skill in math in using formulas and making calculations for sag circuits, frame poles; and amp load for transformers and wire size.
- Skill in using heavy equipment used in performing job duties.
- Skill in writing in order to complete job orders, reports, and related paperwork.
- Ability to communicate clearly by radio.
- Ability to interpret schematics of line constructions, drawings, and underground instructions.
- Ability to follow safety policies and procedures.
- Ability to identify and troubleshoot outages.
- Ability to communicate clearly and concisely.
- Ability to maintain concentration needed to perform duties around energized circuits.
- Ability to analyze and evaluate every job schedule.
- Ability to work with other employees to solve problems.
- Ability to respond to the City of Lockhart City limits or service area within twenty-five (25)

PHYSICAL DEMANDS

The work is heavy work. The employee is constantly required to move objects applying up to 20 pounds of force; frequently required to apply 30 pounds of force to move objects; and occasionally required to exert up to 100 pounds of force to move objects. Additionally, the following additional physical abilities are required (Demand Code: C=Continuously, F=Frequently, O=Occasionally, R=Rarely):
