JOB SUMMARY

Provides Basic and Advanced Life Support including medical evaluation, treatment and stabilization of both non-critically and critically ill or injured patients; responds to emergency rescue situations involving potential loss of life or severe bodily injury; maintains control, manages and directs patient care at the scene of a pre-hospital emergency; provides training and instruction to lesser trained personnel; transports patients, and responds to public assistance calls, both emergency and nonemergency. An incumbent in this position also assists in public health and safety education and participates in related public events activities.

ESSENTIAL JOB FUNCTIONS

- Maintain readiness.
- Render pre-hospital emergency medical care according to established medical protocols.
- Drive assigned units to emergency scenes, transport accident victims and medical patients to hospitals.
- Assist and coordinate with other emergency service agencies in rescue operations, motor vehicle accidents, and other emergency situations.
- Perform a variety of emergency medical treatment services at the basic and advanced life support levels.
- Employ safe lifting and moving techniques.
- Maintain ambulance vehicle (or other assigned vehicle) condition, supplies, and equipment. Assist in training public on cardiopulmonary resuscitation (CPR), standard first aid, and emergency medical techniques. Participate in public health screening.
- Assist staff in performing the full range of advanced life support functions.
- Perform radio communication during emergency and non-emergency situations.
- Writes incident reports, electronic patient care reports, fills out paperwork and files reports.
- Attend court hearings for testimony.
- Cleans station including sweeping and mopping; performs general maintenance duties.
- Participates in related public events.
- Gives station tours.
- Performs other related duties as assigned.

QUALIFICATIONS

Education and Experience:

Requires High School diploma or equivalent, one year emergency medical experience preferred.

Licenses or Certifications:

- Possess and maintain a valid Texas driver's license, Class "C", with an acceptable driving record.
- Possess and maintain a Texas Department of State Health Services Paramedics (EMT-P) Certificate or Licensed Paramedic (LP).
- Possession of, or ability to obtain within six months of hire, an American Heart Association-CPR Card, Advanced Cardiac Life Support Certificate, and Pediatric Advanced Life Support.

Special Requirements:

• Ability to maintain regular, reliable in-person attendance.

Knowledge, Skills and Abilities:

- Knowledge of advanced life support interventions, CPR, and basic life support.
- Learn the geography of local areas.
- Skill in performing basic math computations including addition, subtraction, multiplication, division, calculating percentages, drug calculations, and using formulas.
- Skill in using Office and department software.
- Ability to utilize maps and GPS systems.
- Ability to prepare concise and comprehensive written reports.
- Work 24 to 48 hour shifts to include weekends.
- Be on call 24 hours when necessary.
- Ability to analyze complex information in emergency or dangerous situations.
- Ability to deal with irate, hysterical, frightened, or injured individuals.
- Ability to drive a vehicle on emergency and non-emergency responses.
- Ability to react calmly, promptly, and correctly in emergency situations.
- Ability to understand and follow oral or written instructions in emergency and non-emergency settings.
- Ability to function under adverse conditions.
- Establish and maintain effective working relationships with co-workers and those contacted in the course of work.
- Maintain sufficient personal health and physical fitness to perform all job duties.

PHYSICAL DEMANDS

The work is very heavy work. The employee is constantly required to move objects applying up to 20 pounds of force; frequently required to apply 50 pounds of force to move objects; and occasionally required to exert up to 100 pounds of force to move objects. (Demand Code: C=Continuously, F=Frequently, O=Occasionally, R=Rarely):
