All operators of golf carts on Lockhart streets are required to be licensed pursuant to Texas Transportation Code 521.001 (3) and 521.021, as amended.

All equipment required by Lockhart Code of Ordinances, Section 56-284 for golf carts operated within the Lockhart City limits must be properly installed and kept current and in proper working order during the permit period;

I shall indemnify and hold harmless the City of Lockhart, Texas for and from any and all civil liability, claims, and/or damages associated with or in any way arising from said permitting and the use of the golf cart within the city limits of Lockhart. I waive any and all rights to sue or allow subrogation by any insurance company except as specifically mandated by law.

I, the undersigned applicant, hereby affirm that I am the person who is responsible for this permit. I understand that I am responsible for compliance with ALL applicable laws and any other requirements set forth for the issuance of this permit. I also understand that this permit may be revoked if:

- (a) the owner or driver of a golf cart fails to abide by the Lockhart City Codes;
- (b) the owner or driver of a golf cart fails to abide by state and/or city traffic laws; and /
or
- (c) the owner fails to maintain proof of financial responsibility for the operation of the golf cart on city streets during the entire permit period.
